Spotlight on...

What is the Future of VLJ's?

Last month, we did a spotlight on Light Sport Aircraft and this month we have decided to cover the recent news surrounding Eclipse Aviation and the very light jet. Eclipse Aviation, the Albuquerque manufacturer of the six-seat Eclipse 500 filed for bankruptcy protection on November 25, 2008. The company indicated it was unable to produce its very light jet as fast as its business plan required therefore forcing the manufacturer to take a loss on each aircraft it built.

"In the face of unprecedented economic challenges, it is clear that the sale of the Eclipse business through the Chapter 11 process was the right course of action to maximize the value of the business, secure its future and protect the best interests of Eclipse's stake holders," acting chief executive Roel Pieper said in a news release.

Under Chapter 11, a company seeks an order from a bankruptcy judge that prevents creditors from immediately seizing company assets. Most companies continue to operate in some form while seeking to reorganize and reduce their debt.

"The good news is we're still here and the great news is that someone wants to continue to operate the company," said Mike McConnell, Eclipse's vice president of marketing and sales. Eclipse Aviation plans to sell nearly all its assets – valued at between \$100 million and \$500 million - at a public auction that would be held in January. Barring an offer from a higher bidder, the company would be sold to an affiliate of its largest shareholder, ETIRC Aviation, called EclipseJet Aviation International, Inc.

According to acting chief executive Roel Pieper, the sale will position Eclipse "for aggressive global expansion, allowing the company to fulfill its promise and solidify its position as the world's leading manufacturer of very light jets."

2009 Airport Developments & Projects

This year promises to be another busy year in terms of new facility developments at Whiteman Airport. The new Vista Aviation facility (building and hangars) should be completed early in the year and additional hangars are anticipated to be constructed by other airport tenants. Also to occur early in the year, L.A. County will be constructing approximately 70 new aircraft tiedowns at the old Vista Aviation and Sun Quest site.

Some of the projects anticipated for the New Year include:

- Potential Acquisition and Installation of an AWOS
- Survey to be Conducted and Potential Installation of a LPV Instrument Approach
- Completion of the Airport Master Plan Update
- Development and Implementation of Minimum Standards
- Improvements to the Airport Entrance on Airpark Way and Osborne Street
- Security Enhancements (Access Gate Upgrades and Additional Security Cameras)
