**Hangar Inspections** Last September, we began a program to inspect all aircraft hangars at least annually. The intent of this program is two-fold. First, it will better allow airport management to determine upkeep needs and develop efficient, comprehensive hangar maintenance schedules. Second, the program will ensure compliance with Hangar Parking License Agreements and Los Angeles County Code Title 19, Airports and Harbors (Ord. 9979). Over 50 hangars at Whiteman and about 30 at Compton have already been inspected. Over the next several months, staff at all five airports will be contacting tenants to coordinate mutually convenient inspection appointments.

**Conserving Resources** As we enter another winter season, please do your part to keep the airport energy efficient. It's good for the airport and good for the community. When you leave your hangar for the night, turn off the lights. Unplug that old refrigerator chilling one can of soda. Let us know if you see waste of any utility or resource on the airport. We'll be doing our part by turning off lights and equipment when we aren't in the office. Together, we can make the airport efficient and be good Southern California neighbors.

## **Spotlight on...**

### **Los Angeles County Code Title 19, Airports & Harbors**

Los Angeles County Code, Title 19, Airports and Harbors, (Airport Ordinance 9979) is the citation that regulates and controls activities on L.A. airports. Entry onto any L.A. airport constitutes agreement to comply (19.04.430). American Airports, as contract airport manager, is responsible to ensure all airport users comply with Title 19.

The purpose of regulating and controlling airport activity is to provide for a safe airport environment. The provisions in Title 19 cover a broad range of subjects, from aircraft operations to motor vehicle operations; commercial activity to non-commercial activity; leased space to public use space; fire safety to environmental safety; enforcement powers to violation penalties.

The rules that make our L.A. airports safe are not hard to understand. Most people go about their business every day at the airport, never realizing they are already complying just by using common sense and courtesy. Speed limits are established and posted to reduce the risk of personal injury and property damage (19.04.950). Airport users are required to do their part to keep the airport clean for everyone's sake and to keep operating costs down (19.04.500). Everyone occupying a tie-down, hangar or commercial space must have a legal storage license or lease agreement to ensure all tenants have equal rights (19.04.620, 19.04.520).

When all airport users know and follow the rules, our L.A. airports are safer, more enjoyable and more efficient to operate. You can pick up a copy of Title 19 at the airport office or on-line at:
