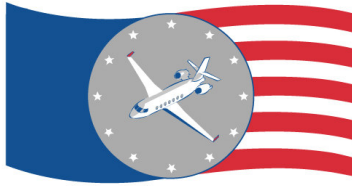

Due to insufficient market, petroleum refineries in the region have stopped production of 80/87 AVGAS. Compton/Woodley Airport recently received one of the last deliveries in the region. Airport Manager Tim O'Donnell anticipates, however, that their supply will last until the end of 2005. Please keep this in mind as you make your future fueling plans.

Spotlight on... Airport Security for GA

On December 10th, 2004, US Government Accountability Office (GAO) released its report on General Aviation Security (www.gao.gov). GAO conducted this study because federal intelligence agencies have reported that in the past terrorists have considered using GA aircraft for terrorist activities. Among other things, the report recommends that the Transportation Security Administration (TSA) develop a plan for implementing a risk management approach to strengthen GA security. TSA says this plan will allow it to establish the need, if any, for minimum security standards at GA facilities. Although security measures at GA airports continue to be almost entirely unregulated by TSA, the agency has partnered with industry and other private sector stakeholders to produce Information Publication A-001, Security Guidelines for General Aviation Airports (www.tsa.gov). This guidance document, issued in May 2004, outlines best use practices applicable to all segments of GA. Both documents recognize the need for active participation and cooperation between airport operators and airport users to keep general aviation secure.

Many of the best use practices suggested are already in place at our LA airports. Perimeter fencing and access control. Security lighting and CCTV. Hangar storage. Local police and sheriff presence on the field, actively facilitated by airport managers. And our staff are on duty round-the-clock to monitor for suspicious activity and alert law enforcement when necessary.

As the airport user and aircraft owner, you have a role to play, too. The most basic method of enhancing GA security is proper securing of aircraft. Propeller and throttle locks and quality hangar door locks are simple, inexpensive ways you can be part of the solution.
