News & Announcements:

Hangar Occupancy: All persons occupying an aircraft hangar, either individually or as co-tenants, must be signatory to the hangar license agreement. If you are sharing or have sub-let your hangar to one or more people who are not named on your license, you may be in violation of LA County Title 19 and/or your license agreement. Until November 1st, airport managers will be offering all those tenants who have or think they may have unlicensed co- or sub-tenants, and all those persons occupying hangars without a valid license agreement an opportunity to come in to the airport office and sign a new license agreement. After November 1st, it may be necessary to seek remedies allowable by Title 19 and the license agreement to ensure everyone on the airport has a valid agreement.

Antique Airplanes & Hot Rods Coming to POC: On October 16, Cal-Rods Presents will hold its Annual Antique Aircraft & Hot Rods Championship on Brackett Airport's SE ramp.
