Insurance Certificates

All tenants are reminded their lease requires a current insurance policy during the term of their hangar, tie-down, or commercial lease. If you have not provided the airport a current certificate of insurance in the past 12 months, please do so. We are in the process of auditing all lease files and you may be contacted by Airport Administration to provide evidence of insurance in the coming weeks.

American Airports requires the following minimum aircraft liability insurance for all non-commercial aircraft:

- \$100,000 per occurrence per person for Bodily Injury
- \$1,000,000 per occurrence for both General Liability and Property Damage
- American Airports Corporation and County of Los Angeles must be listed as additional insured on all policies.

Commercial tenants should check their individual lease for specific insurance requirements.

From the Manager:

The importance of reading your Newsletter: We announce important events and information in your Newsletter. If you do not read them, you may miss out on key info you need to know.

Hangar Inspections: We have inspected about 80% of the LA County hangars at Whiteman. 180+ hangars have been inspected so far, and the tenants of the remaining 20% will be notified and given an inspection date.



Fire Extinguisher Servicing: This service will be performed on 10 October. Please make note and bring your extinguisher to the Airport Office on 6-9 October so that we may provide you with a safe product that could save your life and your aircraft.

Hangar Access: Please provide the airport manager a key to your hangar if you have not already done so. This will allow us to gather up the fire extinguishers when we service them, as well as access in case of an emergency.

Safety and Security First: Please remember that you are the frontline person on the airport to provide the airport staff with information of any strange or improper behavior on the airport. If you notice people who don't seem to belong or are acting in a strange manner, do not hesitate to notify your airport staff. When you enter the gates, please ensure the person coming in behind you, riding in on your gate card, should be coming in. If you are coming in behind someone, please display your gate card so they can see you have one, or display your WHP Hanging Mirror Pass so that they can see you belong here. This is not a right to be rude to someone trying to get in, as the flight school students still have to come through the gate to get to the schools. The flight schools need to tell their students to use the gate keyboard to get entry to their respective schools. If you do not have a hanging mirror pass, they are free, just come by with proof of insurance on your car and the license plate number, and we will issue you one.
