Contract Control Tower **Funding Update.** The Federal Government's fiscal year ends September 30th and with that the funding for Contract Control Towers. There seems to be cautious optimism that some sort of temporary funding will be approved though that will keep the tower open in the short time, possibly until December 15th according to the American Association of Airport Executives (AAAE). A key question though is whether or not the FAA will take steps in the near term under a continuing resolution to close towers, arguing that doing so is necessary because of likely funding reductions later in the fiscal year. Many members of Congress however are supporting the continued funding of the contract towers and would probably not be in support of the closures.

Funding beyond any continuing resolution and through the 2014 fiscal year remains an open question however. The FAA stated in a meeting with industry representatives this summer that sequestration could force an additional \$697 million in cuts. FAA Administrator Huerta warned that those cuts could include furloughs, deferring controller hiring and

shrinkage of services. Specific examples of shrinking services identified by the Administrator included phased out funding for contract towers, flight service stations, and contract weather observers.

Knowing this I urge you to continue to make your voice heard to your congressional representation letting them know that our tower is an important and necessary asset that helps keep our airport, the surrounding airports and the neighboring community safe.

Whiteman Airport Open House. Our annual Airport Open House will take place on Saturday, October 26th from 10 am until 2 pm. The event will be held in the grassy area in front of the Administration Office as well as on the adjacent transient parking ramp. GAO Worried About Controller Shortage

The FAA says it needs to train 11,700 new air traffic controllers in the next eight years to cover retirements and budget-related staff cuts, but the Washington Times reports the General Accounting Offices is worried the agency's training arm won't be able to do it. For the past several years, the FAA has been trying to devise programs to speed up the training of controllers. The result is that it now takes 2.68 years to certify a controller compared to 1.9 years in 2009. The GAO says part of the problem is the revolving door in the training department at the FAA. In four years, there have been three reorganizations and no fewer than 20 initiatives started to speed up the training process. None of those initiatives has been completed.

Meanwhile, the GAO says the goal of ensuring all controllers get proper rest before their shift has been met with roughly 1 percent of controllers arriving for work without the required rest period. "Ensuring a well-rested, alert controller workforce is essential to the safe and efficient operation of the [national airspace system]," the GAO said. After a spate of high-profile incidents in which controllers were found sleeping during their shifts, the FAA enacted new rest rules. It also added a second person to graveyard shifts at facilities that only had one person on duty. The GAO says the agency should eliminate overnight shifts at 72 facilities that don't have the traffic to warrant them to save some of the \$1.9 million the extra staffing and longer rest periods are costing the FAA.
