#### New ATIS Telephone Number: (818) 899-9820

If you haven't already heard, we now have a telephone number for our Automated Terminal Information Service (ATIS). The information is updated every hour (or more frequently, to provide special updates) between 8:00 a.m. and 8:00 p.m. daily, and is also available on frequency 132.10 Mhz.

#### Airport Safety / Security / Operational Items

Consistent with the recommendations from the Runway Safety Action Team, we have recently formalized the gate access control card application process. All entities assigned an access control card (allowing access to the airside of the airport) are required to complete an application, provide supporting information, and acknowledge that they have read, understand, and will comply with the general policies for the use of the gate access control cards. The policies are consistent with Title 19 and promote the safe operation of vehicles on the airside of the airport by authorized individuals.
