Letter from the Manager:

<u>Calling for Fuel</u>: When calling for fuel, please remember to use either the **Unicom Frequency (122.95)** or the new fuel phone number **(818-312-2911)**.

Hangar Maintenance: If you are in Hangar Row H, please contact airport management about allowing the operations staff to check the springs and doors on your hangar. If your hangar is even-numbered (2, 4, 6, etc.), please be available on Aug 21, or leave us your key. If your hangar is odd-numbered (3, 5, 7, etc.), please be available on Aug 22, or leave us your key.

FAA Monthly Seminars: We will hold an FAA Safety Seminar every month. August's meeting is on the 19th, the topic: "Aviation Insurance 4 Everybody". <u>Fuel Prices:</u> Avgas is \$3.14 per gallon off the truck / \$3.04 at the self-serve, and Jet is now \$2.76.

<u>Vehicle Parking on WHP</u>: Please remember that you are not permitted to permanently park vehicles on Whiteman. You can park your vehicle in the footprint of your tie-down or within your hangar while you are flying. You cannot use Whiteman to park vehicles for any other duration without prior permission from the airport manager. We are towing unauthorized vehicles.

<u>Hangar Inspections:</u> We will start hangar inspections around 2 August. We will start with Hangar Rows U, BB, CC, DD and T. The inspections will be done from 9 AM to 5:30 PM Monday through Thursday. Row U will be 2-5 August; Row BB, 9-12 August; Row CC will be 16-19 August; DD will be 23-26 August; and T will be 30 August to 2 September. Please contact the airport manager's office to coordinate the date of your inspection. According to the Hangar Parking agreements: "Licensee shall permit Manager free access to licensed Premises at all times during business hours and at reasonable times thereafter without notice, except in the case of emergency during which, or in anticipation of which, Manager shall have access at any and all times." In the spirit of cooperation, I am giving a great deal of notice to allow you to prepare in advance. The goal is to inspect all hangars on Whiteman on a quarterly or semi-annual basis unless it is deemed to be needed more often.

Please have proof of ownership of the aircraft and current insurance for your aircraft available for verification. I promise this will be as un-intrusive as possible. The need for this is to verify what is in the hangar and ensure it is safe from fire hazards and free of any dangers to the neighboring hangars and the community.

Entry to Airport: Please remember that entry into the gates of the airport is limited to one vehicle at a time. You can help enforce this security measure by waiting for the gate to close behind your vehicle before proceeding to drive onto the airport premises. There will soon be a sign posted to that effect.

<u>Underground Trenching:</u> There will be work done on the taxi lane between Row 24 and the M&D hangars for the next month. The taxi lane has a shorter width and should only be used by those tenants of the M&D hangars on that side. The work being done is the placement of the above ground power lines underground. This will eliminate the poles that exist now. The main taxi way, parallel to the runway, that runs behind Vista Aviation and Sun Quest will temporarily be blocked at the point where the taxi lane and taxiway cross/intersect, for about 3 days in the week of 23 July. The end result will be an increased safety zone (no poles to run into).

<u>Tie-Down Movement</u>: In the next month, we will be adding more tie-downs at the ends of Rows 17-24 (toward the taxiway). This will decrease the amount of space you will have in which to drive your car, so please take note and drive slower and more safely. We will also eliminate other tie-downs due to the beginning of construction of a 9-hangar commercial complex.

Tenants Bothered by Photo-takers: I have been called quite a bit recently by tenants who are bothered by people driving up to them in their hangars or tie-downs, and taking photos of them. Please note who it is, I will need a vehicle type and license number, and a written complaint. Once I have that, I will remove the offender(s) from the premises, unless you give them permission to take the photos. You have a right to enjoy your tie-down and hangar in peace without being harassed.
