January Commission Meeting

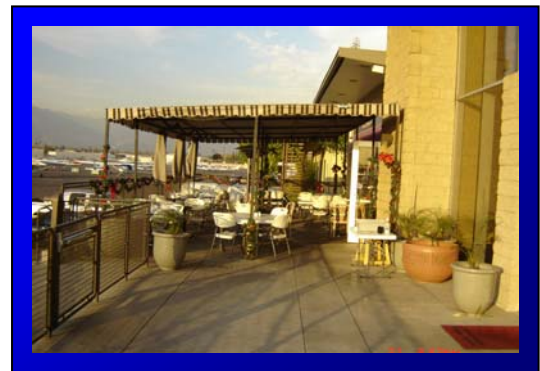

From the Manager:

Happy New Year! All of us at AAC are looking forward to a new year of continued efforts toward ensuring that Whiteman Airport is safe, secure, compliant and compatible with high-quality products, services, and facilities – overall, a great general aviation airport to visit or to call home.

Runway & Taxiway Project Completed: The Runway, Taxiway, and Helpads have been resurfaced with slurry seal, and two coats of glass-bead paint have been laid down for the markings. We were also able to re-stripe the taxiway centerlines throughout the Airport. Your patience and cooperation have been greatly appreciated.

We will be looking into placing reflective markers/dots along the taxiway centerlines and painting a new compass rose on the Airport. We will keep you posted on any upcoming improvements to the Airport facilities.

Airport Tenant is Moving Up! Vista Aviation will be relocating to the east side of the Airport adjacent to Airpark Way. With plans to develop just over 4.5 acres of land to include ramp, vehicle parking, terminal building, and aircraft hangars, Vista will continue to offer flight training, aircraft rental, aircraft maintenance, avionics and sales. Groundbreaking is anticipated for early January. If you have any questions or would like to inquire about hangar availability, please contact Vista at (818) 896-6442.

Airport Safety and Security Items: Reminders are helpful for all of us and these newsletters are certainly a useful tool to regularly review safety and security items at the Airport. This month we would like to review two items in our continual effort to improve safety and security at the Airport: 1) vehicle traffic; and 2) animals on the airside of the Airport.

Airport Speed Limit: The speed limit for vehicles on the Airport is 10 miles per hour.

Off-Leash Dogs: Dogs and other animals must be kept on a leash or confined in such a manner as to be under control at all times while on the Airport. Please report lost or stray animals to our Operations Staff at (818) 312-2911.

Both of these requirements are consistent with Los Angeles County Code, Title 19 – Airports and Harbors. If you have any questions or comments, please contact the Airport Administration Office at (818) 896-5271.

Hangar Inspections: We thank all of you who have made your hangar(s) available for inspection. We have several hangars that still require inspection. If you have not had your hangar inspected yet, please contact the Airport Administration Office as soon as possible to schedule an inspection.
