Spotlight on... CAP's Cadet Program

You are probably aware that the *Civil Air Patrol* comprises those volunteers who look for you when you don't show up at your destination airport. Besides donating over 10,000 hours' volunteer search time each year (out-of-pocket search costs are underwritten by their USAF parent organization, saving 50+ lives each year), the CAP also takes part in disaster relief missions (e.g., looking for Hurricane Katrina survivors), border surveillance and reconnaissance flights for ICE and the DEA, and other special Emergency Services missions (such as looking for debris after the Space Shuttle disaster).

Perhaps the least widely known portion of CAP is their <u>Cadet Program</u>, sometimes mistaken for the similarly attired Air Force Junior ROTC Cadets. CAP's Cadet Program is similar to an Explorer program for the Air Force, with weekly evening meetings and frequent weekend activities. Cadets range from 12 to 21yr., but Cadet membership must begin before age 18.

CAP Cadets not only get to learn firsthand about aerospace and flying, but do so in a program that also teaches practical skills in leadership, self-discipline, problem solving, teamwork, and other areas that will serve them well in their future. Not a recruiting program, it uses the natural fascination of young people with action and adventure to teach them valuable skills, while providing worthwhile activities and maintaining high standards of behavior and performance. Their standards of conduct are modeled after military customs and courtesies: saluting officers; saying "Yes, sir"; and other tools of learning responsibility and civility.

Cadets have numerous opportunities to fly; tour aerospacerelated facilities to learn about aviation; learn about Emergency Services and outdoor survival skills; participate in adventure activities including marksmanship, model rocketry, hiking, and wilderness camping; and enjoy serving their communities and growing into great human beings.

In Los Angeles County, CAP squadrons are based at 4 of the 5 County airports (Brackett, El Monte, Fox and Whiteman), and at numerous other local airports and other locations. From the Manager:

With summer fast approaching, we are busy taking care of seasonal maintenance and repairs to the Airport's facilities and improvements. Some of the projects anticipated for May

- Fire Extinguisher Program: Nearing the completion of the hangar inspections, we intend to service (replenish or replace) fire extinguishers in hangars throughout the Airport and we want to ensure that ample notice has been provided so that the project can be effectively coordinated. Specific details regarding the Program will be provided in next month's newsletter. In the meantime, if you have any questions, please contact the Airport Administration Office.
- Reflective Taxi Lane Centerline Markers: The installation of reflective markers along the centerline of the taxi lanes. This effort is a direct result of feedback from Airport tenants and we hope that the reflective markers will facilitate the safe movement of aircraft at the Airport.

Airport Safety / Security / Operational Items: It was brought to my attention that some people may be operating their aircraft engines at high-power settings in close proximity to other parked aircraft. If your tiedown or hangar space requires that you utilize high-power settings to taxi into or out of it, please let Airport Management know so we may look into moving the aircraft to a more compatible and functional location. At all times, please operate aircraft engines in a manner or position that ensures that hangars, buildings, or other facilities, property or persons are not damaged or injured by such operation. Your consideration and cooperation are greatly appreciated.

Also, we'd like to pass along a brief reminder to take extra care in securing your hangar and/or tiedown. The seasonal winds have been extra strong this year, and ensuring that your aircraft is properly secured and tied down and/or your hangar door is securely closed and locked while not in use will greatly reduce the potential for damage.
