- Fox: Runway/Taxiway – **in progress**
- Whiteman: Runway/Taxiway – **in progress**

Fox Airfield Pavement Rehabilitation Project:

- Phase II – **completed**

Runway & Taxiway Closures

The dates have been set, barring any weather-related delays, for the repair/enhancement work to be done on the Runway and Taxiway. The Runway will be closed **7 a.m. to 10 p.m. on Thursday, October 26, 2006** for crack fill and repair. The Runway will also be closed **7 a.m. on October 31, 2006 through 10 p.m. on November 2, 2006** for slurry sealing and re-striping.
