From the Manager:

The Importance of Reading Your Newsletter: We announce important events and information in your newsletter. If you do not read them, you may miss out on key info you need to know.

<u>Calling for Fuel</u>: When calling for fuel, please remember to use either the <u>Unicom Frequency</u> (122.95) or the fuel phone number (818-312-2911).

<u>Common Courtesy:</u> We have had several complaints about people pulling their aircraft out of their hangars and doing a pre-flight/post-flight or just walking away and leaving it in the taxiway. Please be considerate and do not block any taxiways for any time longer than necessary. HH Row seems to be getting the most complaints, but there are a few other areas of the Airport people are worried about.

<u>Derelict Aircraft:</u> We have noticed that there are a great many aircraft on the field that could not be rolled/moved if there was a fire because they have at least one flat tire. According to Title 19, your aircraft should be airworthy or on its way to being airworthy. If you have an aircraft with flat tires, please ensure the tires are inflated by 1 December 2005. It is good for the safety of all parked aircraft that they can be moved in case of an emergency to mitigate damage caused by fire. Thank you for your help.

<u>Hangar Access:</u> Please provide the Airport Manager a key or the combination of your lock to your hangar, if you have not already done so, by 1 December. A key will allow us to gather up the fire extinguishers when we service them, or to have access in case of an emergency.

Safety and Security First: Please remember that you are the frontline person on the Airport to provide the Airport Staff with information of any strange or improper behavior on the Airport. If you notice people who don't seem to belong or are acting in a strange manner, do not hesitate to notify your Airport Staff immediately. When you enter the gates, please ensure the person coming in behind you, riding in on your gate card, should be coming in. If you are coming in behind someone, please display your gate card so they can see you have one, or display your WHP Hanging Mirror Pass so that they can see you belong here. This is not a right to be rude to someone trying to get in, as the flight school students still have to come through the gate to get to the schools. The flight schools should be telling their students to use the gate keyboard to get entry to their respective school. If you do not have a hanging mirror pass, they are free, just come by with proof of insurance on your car, and the license plate number, and we will issue you one.

FAA Monthly Seminars: There is an FAA Safety meeting every month. To find out what date and topic the meeting will be, please go on the Web to: http://faasafety.gov . It will be held in the CAP trailer.

Aviation Fuel Pricing: While the price of fuel per barrel is coming down, the cost of Avgas and Jet A has seen a large increase. We hope to see an end to this trend by December, but please note that AAC's cost per gallon of Avgas has gone up significantly since July.
